

## Agreement and Declaration of Candidacy

I understand that, due to the expectations of my advisors / administration and the demands of a growing Student Government program AND a growing Student Body population, I will not be participating in extracurricular activities such as athletics, band, drama, cheer, or drill, (ie., Performing Groups) **without first consulting with the Student Government advisors and Assistant Principal over Student Government.** I understand that before participating in extracurricular programs or activities that may conflict with student government programs or activities that there will be a plan in place, agreed upon by the student, parents, coaches and/or Instructors, Student Government Advisors, and Administration, that will outline how the demands of both programs will be met by the student.

Failure to meet the responsibilities of the Student Government program, (i.e., participating in activities, planning sessions, assigned administrative duties, set-up and teardown of dances, assemblies, and other projects, participating in Sophomore Orientation, Parent/Teacher Conferences, Weekly Hearts of Gold activities, mandatory leadership conferences, and other activities assigned by the student government advisors and/or Administration) will result in being placed on probation. *I understand on the second occurrence of being placed on probation due to my failure to meet the responsibilities of the student government program, I will be removed from office.*

I know my time will be spent supporting, attending and promoting school activities and programs. In addition, I will also be attending mandatory conferences, meetings, and other leadership programs throughout the school year at HHS and other Locations (Dixie, UVU, UofU, BYU).

I understand the significance of my responsibilities and the role that I will play in contributing to the success of HHS and its programs and activities. I will complete my duties as a Student Government Officer while maintaining my grades and any additional responsibilities required as a student at HHS. I am aware that if I fail to meet the minimum grade standard of 3.0, or if I receive a failing grade, an incomplete, or a no-grade, for any of the four quarters that I hold this office, and 4th quarter of 2018, I will be placed on probation. *I understand on the second occurrence of being placed on probation due to grades, I will be removed from office.*

I know that being a Student Government Officer at Herriman High School requires a total commitment and my signature indicates that I am willing and ready to make this commitment, agree to adhere to all guidelines within the Herriman High School Student Government Code of Conduct, and other guidelines found in this packet.
